3 **O'odham Nation Education Department's One Stop Division for the period beginning**
4 **April 1, 2011 to June 30, 2013 in the amount of \$238,556.00; and**

5 **WHEREAS, the Department of Economic Security - State of Arizona anticipates allocation of**
6 **funds to the Nation, for FY2012 in the amount of \$238,556.00, the funds allocated are**
7 **subject to the provisions of the Workforce Investment Act Title 1B; and**

8 **WHEREAS, the Education Department - One Stop Division has seven (7) program budgets and**
9 **request to expend these budgets per attached budgets; and these budgets are**




