

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting 2011-2013 Legislative Council Committee Meeting Schedule)**

**LEGISLATIVE ORDER NO. 11-268**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the . . . standing committees" (Constitution,**  
3 **Article VI, Section 1(a)); and**

4 **WHEREAS, "the legislative committees of the Legislative Council are the standing committees of**  
5 **the Legislative Branch performing continuing functions for an indefinite time, whose**  
6 **membership shall consist of representatives to the Legislative Council." (Legislative**  
7 **Rules of the Tohono O'odham Legislative Council, Article XI, Section 1(A)(1)); and**


8 **WHEREAS, on June 17, 2011, following the election of Chairperson, Vice-Chairperson, and**  
9 **selection of Secretary, the Tohono O'odham Legislative Council elected committee**  
10 **members and officers to the Council's 12 standing committees; and**

11 **WHEREAS, the Legislative Rules Committee has drafted a schedule listing regular Legislative**  
12 **Council committee meetings for 2011-2013.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it adopts the**  
14 **"2011-2013 Legislative Council Committee Meeting Schedule," which is dated for**  
15 **reference June 22, 2011 and which shall remain in effect until committee**  
16 **memberships are elected following the Nation's 2013 general election.**


17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day of**  
18 **JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 a of**  
20 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
