

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting July 6, 2011 Special Session for a Report on the Trust Asset Management Litigation  
and Discussion on Related Matters)**

**LEGISLATIVE ORDER NO. 11-270**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**


5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**  
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**  
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Trust Settlement Delegation has requested a special session for July 6, 2011 at 3:00**  
9 **p.m. for a report on the trust asset management litigation and discussion on related**  
10 **matters.**

11 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
12 **sets a special session for July 6, 2011 at 3:00 p.m. for a report on the trust asset**  
13 **management litigation and discussion on related matters.**


14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> day of**

17 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
