

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation's "2011 Indian Housing Plan")

RESOLUTION NO. 11-271

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **power to enact laws "to promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members" (Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:ki Association ("TOKA") is the Nation's tribally designated**
6 **housing entity in accordance with the Native American Housing Assistance and Self-**
7 **Determination Act of 1996, 25 U.S.C. §4101, et seq., P.L. 104-330, 110 Stat. 4016**
8 **("NAHASDA"); and**

9 **WHEREAS, to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA**
10 **requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe**
11 **or by the tribe's designated housing entity (25 U.S.C. §4112); and**

12 **WHEREAS, pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,**
13 **Chapter 1, the TOKA shall submit annually to the United States Department of**
14 **Housing and Urban Development's Southwest Area Office of Native American**
15 **Programs ("SWONAP") the Nation's Indian Housing Plan after review and approval**
16 **by Legislative Council resolution (TOKA Ordinance, Article IX, 1., [http://tolc-](http://tolcnsn.org/docs/Title18Ch1.pdf)**
17 **nsn.org/docs/Title18Ch1.pdf); and**

18 **WHEREAS, under the direction of the TOKA's executive director, the TOKA prepared and**
19 **submitted the Nation's 2011 Indian Housing Plan for the program year beginning**
20 **July 1, 2011 and ending June 30, 2012 to TOKA's Interim Board of Directors for review**
21 **and approval (TOKA Ordinance, Article IX, 1, b., ii.); and**

22 **WHEREAS, after approving the Nation's 2011 Indian Housing Plan by Resolution No. 06-08-11,**
23 **the TOKA's Interim Board of Directors provided the IHP to the Legislative Housing**
24 **Committee for review and approval (TOKA Ordinance, Article IX, 1, b., iii.); and**

25 **WHEREAS, the Legislative Housing Committee recommends approval of the Nation's 2011**
26 **Indian Housing Plan for the program year beginning July 1, 2011 and ending June 30,**
27 **2012.**

28 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
29 **the Nation's "2011 Indian Housing Plan"; provided that any amendments are subject**
30 **to Legislative Council review and approval.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
32 **Nation's Chairperson to sign the certification authorizing submission by the TOKA**
33 **of the Nation's 2011 Indian Housing Plan.**


