

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting June 30, 2011 Special Session for Approval of TOFA Bank of America Loan Agreements)

LEGISLATIVE ORDER NO. 11-272

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**


5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Budget and Finance and Agricultural and Natural Resources Committees request**
9 **a special session of the Legislative Council on June 30 at 10:00 a.m. to review and**
10 **approve the Bank of America loan agreements for the Tohono O'odham Farming**
11 **Authority (TOFA) .**

12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**
13 **special session for June 30, 2011 at 10:00 a.m. for review and approval of the Bank of**
14 **America loan agreements for the Tohono O'odham Farming Authority (TOFA) and any**
15 **other matters which may be added to the agenda.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 24TH day of**
17 **JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,535.70 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and 244.90[07] ABSENT, pursuant to the powers vested in the Council by Section**
19 **1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
20 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
