

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Appropriation in the amount of \$90,000 for the Office of the
Chairman & Vice Chairwoman for FY2011)

RESOLUTION NO. 11-275

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Fiscal Year 2011 Tribal**
2 **Budgets (Resolution No. 10-295) which included the budget for the Office of the**
3 **Chairman & Vice Chairman; and**

4 **WHEREAS, the Tohono O'odham Nation Chairman and Vice Chairwoman have recently entered**
5 **into their current four-year term as elected officials and have inherited vehicles that**
6 **have previously been utilized by the prior Administration that has accrued extensive**
7 **mileage; and**

8 **WHEREAS, it is necessary to replace vehicles for the Chairman and the Vice Chairwoman as they**
9 **are required to drive extensively throughout the Tohono O'odham Nation of 2.8**
10 **million acres of land and off the Nations land; and**

11 **WHEREAS, Budget and Finance Committee of the Legislative Council have reviewed this budget**
12 **and recommend its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approve and**
14 **appropriates \$90,000.00 from Nation's general surplus fund and to add line item 750**
15 **Major Capitol Equipment, per the attached budget for the Office of the Chairman**
16 **and Vice Chairwoman of the Tohono O'odham Nation.**

17 **BE IT FURTHER RESOLVED that this approval is for a one-time funding appropriation and that all**
18 **unused funds from this appropriation is to be returned to the Nation's general**
19 **surplus fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation Chairperson, and any designated officials are authorized to expend and**
22 **administer the budget as attached, provided that any amendments affecting the**
23 **funds or funding levels that are budgeted shall be submitted for prior approval by**
24 **the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
26 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 1,904.15 FOR; 649.75**
27 **AGAINST; -01- NOT VOTING; and 226.70[04] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**


