

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2011 Budget Amendments for San
Luis Community (*Amendment #1*) and Santa Rosa Community (*Amendment #1*))**

RESOLUTION NO. 11-277

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on June 30, 2011 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on May 27, 2011 at a regularly scheduled meeting, the Gu Achi District Council did**
4 **approve budget amendments for San Luis Community (*Amendment #1, Resolution***
5 ***#0511-490*) and Santa Rosa Community (*Amendment #1, Resolution #0511-489*); and**

6 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**
7 **review the district's budget amendments submitted by the Gu Achi District and**
8 **recommend for approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve the Gu Achi District Fiscal Year 2011 Budget Amendments for San Luis**
11 **Community (*Amendment #1*) and Santa Rosa Community (*Amendment #1*) with**
12 **attached documentation hereto.**

13 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
14 **Distribution of \$1,705,922.80 allocated to the Gu Achi District.**

15 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
16 **Year 2011 budget in accordance with protocols set forth by this Council. Any**
17 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal**
18 **Year 2011 budget shall be approved by the Tohono O'odham Legislative Council.**

19 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
21 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and 226.70[03] ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
