

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Appointments of Representative Frances G. Antone and Representative
Sandra Ortega as the National Indian Health Board Tucson Area Representative
and Alternate)

RESOLUTION NO. 11-291

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult "with the**
2 **Congress of the United States and appropriate federal agencies regarding federal**
3 **activities that affect the Tohono O'odham Nation" and to consult "on behalf of the**
4 **Tohono O'odham Nation with Federal, State and local governments and other Indian**
5 **tribes or their departments, agencies, or political subdivisions, or with private**
6 **persons or organizations on all matters within the authority of the Tohono O'odham**
7 **Council." (Constitution, Article VI, Section 1, (j) and (f)); and**

8 **WHEREAS, the National Indian Health Board ("NIHB") is a nonprofit organization that consults**
9 **with the United States Congress and federal agencies on national Indian health**
10 **policies and advocates to improve health care delivery to all Native Americans; and**

11 **WHEREAS, NIHB's membership consists of the area health board in each Indian Health Service**
12 **("IHS") area and, in an IHS area where there is no health board, the NIHB designates**
13 **an organization within that area as the member; and**

14 **WHEREAS, the IHS Tucson Area has no health board and the Tohono O'odham Nation has**
15 **appointed a representative and an alternate to the NIHB for many years (Resolution**
16 **No. 07-427, available at <http://tolc-nsn.org/docs/actions07/07427.pdf>); and**

17 **WHEREAS, in accordance with Article III, Section 2 of the Amended Constitution and By-laws of**
18 **the NIHB, NIHB representatives are required to be tribal officials such as council**
19 **members, health board members, or health directors; and**

20 **WHEREAS, Legislative Council Representative Cynthia Manuel was previously appointed as the**
21 **NIHB Tucson Area representative, but no longer serves as a member of the Legislative**
22 **Council Health and Human Services Committee, which is the standing committee with**
23 **primary oversight jurisdiction over health-related matters; and**

24 **WHEREAS, the Health and Human Services Committee recommends that Representative Frances**
25 **G. Antone replace Cynthia Manuel as the NIHB Tucson Area representative and that**
26 **Representative Sandra Ortega serve as Representative Frances G. Antone's alternate.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

28 **(1) Appoints Representative Frances G. Antone as the NIHB Tucson Area**
29 **representative and appoints Representative Sandra Ortega as Representative**



(2) Requests that the NIHB recognize Representative Frances G. Antone as the official NIHB Tucson Area representative and Representative Sandra Ortega as Representative France G. Antone's alternate.

BE IT FINALLY RESOLVED that an appointment made pursuant to this resolution shall supersede any prior appointments to the NIHB and shall immediately expire if the appointed representative no longer serves on the Health and Human Services Committee for any reason.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12th Day of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,542.75 FOR; 237.85 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (b) 1(c)(2) 1(f) and 1(j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


