

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Acceptance of Wildlife Donation from United States Fish
and Wildlife Service)**

RESOLUTION NO. 11-292

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "purchase or**
2 **otherwise acquire property." (Constitution of the Tohono O'odham Nation, Article VI,**
3 **Section 1(i)(3)); and**

4 **WHEREAS, the United States Fish and Wildlife Service has offered to donate the following items**
5 **to the Tohono O'odham Nation's Wildlife and Vegetation Management Program: one**
6 **Ringtail cat pelt, one bobcat pelt, five sets of deer antlers, one shoulder mount white-**
7 **tailed deer trophy, one tiger skull, one Beaded lizard skin, one set of bighorn sheep**
8 **horns, two live desert tortoise; and**

9 **WHEREAS, the Wildlife and Vegetation Management Program intends to use the items donated**
10 **by the United States Fish and Wildlife Service for educational purposes; and**

11 **WHEREAS, the Wildlife and Vegetation Management Program has met and discussed the**
12 **donation with the Legislative Council's Natural Resource and Cultural Preservation**
13 **Committees; and**

14 **WHEREAS, if in the future similar donations are offered from the U.S. Fish and Wildlife Service,**
15 **the Wildlife and Vegetation Management Program will inform the Natural Resource**
16 **and Cultural Preservation Committees.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it accepts the**
18 **donation from the United States Fish and Wildlife Service of one Ringtail cat pelt, one**
19 **bobcat pelt, five sets of deer antlers, one shoulder mount white-tailed deer trophy, one**
20 **tiger skull, one Beaded lizard skin, one set of bighorn sheep horns, and two live desert**
21 **tortoise to be used for educational purposes by the Wildlife and Vegetation**
22 **Management Program.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12th Day**
24 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,552.20 FOR; 228.40**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (i)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
