RESOLUTION NO. 11-293

1 **WHEREAS, the Arizona Department of Economic Security Intergovernmental Agreement for the**
2 **Low Income Home Energy Assistance Program (LIHEAP) has been received for contract**
3 **period of July 01, 2010 through June 30, 2015; and**

4 **WHEREAS, the Low Income Home Energy Assistance (LIHEAP) is funded on a year to year basis by**
5 **the Arizona Department of Economic Security (ADES), through an Intergovernmental**
6 **Agreement; and**

7 **WHEREAS, the State allocation for the LIHEAP is awarded on a year to year basis for the period**
8 **beginning July 01, 2010 to June 30, 2011; and**

9 **WHEREAS, the Executive Branch developed and obtained committee approval of the Arizona**
10 **Department of Economic Security Intergovernmental Agreement for the LIHEAP for**
11 **the period beginning July 01, 2010 to June 30, 2015; and**

12 **WHEREAS, the Health and Human Services Committee, Domestic Affairs, and the Budget and**
13 **Finance Committee of the Legislative Council have reviewed the Arizona Department**
14 **of Economic Security Intergovernmental Agreement for the LIHEAP and recommend**
15 **acceptance for its approval and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts,**
17 **approves and authorizes the Family Assistance Division, Low Income Home Energy**
18 **Assistance (LIHEAP) Department of Economic Security, Intergovernmental Agreement**
19 **for period of July 01, 2010 through June 30, 2015.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
21 **Chairperson and any designated official to sign, administer and execute the Arizona**
22 **Department of Economic Security Intergovernmental Agreement for the LIHEAP in**
23 **substantially the form attached hereto; provided however that any amendments**
24 **affecting the agreement amount shall be submitted for further prior approval by the**
25 **Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th Day**
27 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,576.0 FOR; -0- AGAINST;**
28 **-0- NOT VOTING; and 204.60[03] ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**






