

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Department of Health and Human Services, Division of Family**  
**Assistance – FY11 Low Income Home Energy Assistance Program (LIHEAP)**  
**Budget Amendment #1, Account No. 12-1310)**

**RESOLUTION NO. 11-294**

1 **WHEREAS, by Resolution Number 10-317 the Tohono O'odham Legislative Council approved the**  
2 **Low Income Home Energy Assistance Program budget in the amount of \$62,572.00; and**

3 **WHEREAS, the Tohono O'odham Nation's award for FY 2011 funding through the State of Arizona,**  
4 **Department of Economic Security, Community Services Administration was increased**  
5 **from \$62,572.00 to \$72,531.00 for contract period July 01, 2010 through June 30, 2011;**  
6 **and**

7 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division, Low**  
8 **Income Home Energy Assistance Program (LIHEAP) has submitted the attached budget**  
9 **amendment #1 which increases Line Item 720 Supplies-Office; 858 LIHEAP Payments;**  
10 **and an increase to Line Item 900 Indirect Cost from \$553.66 to \$737.04 for a total**  
11 **budget of \$72,531.00; and**

12 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**  
13 **Assistance Division, Low Income Home Energy Assistance Program budget**  
14 **amendment #1 which is attached and incorporated by this reference to be effective**  
15 **July 01, 2010 through June 30, 2011 and requests authorization to expend funds; and**

16 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
17 **of the Legislative Council have reviewed this budget amendment and recommend its**  
18 **approval and adoption.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
20 **authorizes the budget amendment #1 which reflects increases in line items 720**  
21 **Supplies Office; 858 LIHEAP Payments; and an increase in Line Item 900 Indirect Cost**  
22 **from \$553.64 to \$737.04 for a total budget of \$72,531.00 and authorizes the Executive**  
23 **Branch to expend funds in the attached Family Assistance Low Income Home Energy**  
24 **Assistance Budget Amendment #1 effective July 01, 2010 through June 30, 2011. The**  
25 **budget amendment reflects an increase from \$62,572.00 to \$72,531.00 which is an**  
26 **increase of \$9,959.00.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
28 **Chairperson and any designated official to expend and administer the budget as**  
29 **attached, provided that any amendments affecting the funds or funding level shall be**  
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
