for Credit & Finance Program)

RESOLUTION NO. 11-299

1 **WHEREAS, the Planning and Economic Development Department's Credit & Finance Program**
2 **provides for business development, management and technical assistance; and**

3 **WHEREAS, the Credit & Finance Program has reviewed its FY 2011 Budget, the program will need**
4 **to amend the FY-2011 budget to increase line items; and**

5 **WHEREAS, Credit & Finance Program is requesting to decrease line item 650 Tuition and**
6 **Registration; 655 Lodging; 660 Travel Expense the total of these funds will be**
7 **distributed to other line items that require an increase; and**

8 **WHEREAS, Credit & Finance Program is requesting to increase 720 Supplies Office, 772 RM**
9 **Building, 810 Professional Services and 812 Public Relation; and**

10 **WHEREAS, due to the amendment requested Line Item 900 Indirect Cost Charges will decrease**
11 **from the total of \$41,399.11 to \$41,062.71; and**


12 **WHEREAS, the Commerce and Budget & Finance Committees have reviewed and approved the**
13 **Credit & Finance Program FY-2011 Budget Amendment #2.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the Credit & Finance Program FY-2011 Budget Amendment #2 in accordance with the**
16 **budget attached.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
18 **the Chairperson and any designated official to expend and administer the budget, as**
19 **attached, provided that any amendments affecting the funds or funding levels of the**
20 **budget shall be submitted for further prior approval by the Tohono O'odham Nation**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th Day**
23 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
25 **and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
