

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the IGA between the Northwest Fire District (a State of Arizona Fire District) and the Nation)**

**RESOLUTION NO. 11-300**

1 **WHEREAS, the Tohono O'odham Nation Fire Department seeks to enter into an**  
2 **Intergovernmental Agreement (IGA) with the Northwest Fire District, Ironwood**  
3 **Hotshots (a State of Arizona Fire District) for professional services to be provided by**  
4 **the Northwest Fire District to the Nation, specifically fuel reduction and vegetation**  
5 **removal services on the Kitt Peak Mountain Range; and**

6 **WHEREAS, the Northwest Fire District will conduct fuel reduction and vegetation removal**  
7 **services at the designated target areas on the Kitt Peak Mountain Range and the**  
8 **Nation will pay the Northwest Fire District an hourly rate for the services; and**


9 **WHEREAS, the attached IGA has been reviewed by the Domestic Affairs Committee which**  
10 **recommends Legislative Council approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the IGA with the Northwest Fire District, Ironwood Hotshots, substantially in the form**  
13 **attached hereto, and authorizes the Chairman of the Nation to sign and execute the**  
14 **IGA.**

15 **BE IT FINALLY RESOLVED that Tohono O'odham Legislative Council authorizes the Chairman to**  
16 **expend and administer the budget as attached, provided that any amendments**  
17 **affecting the funds or funding level shall be submitted for further approval by the**  
18 **Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>th</sup> Day**  
20 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) and**  
22 **1(1) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
