

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2011 Budget Modification Amendment # 1 for Head Start  
Technical and Training account #11-1228 and adding line item)**

**RESOLUTION NO. 11-301**

1 **WHEREAS, the Tohono O'odham Nation through the Division of Early Childhood Development**  
2 **Head Start Program has successfully provided services and assistance to eligible**  
3 **Tohono O'odham children and their families; and**

4 **WHEREAS, the Head Start program, through the grants and contracts office has received**  
5 **\$23,205.00 for the 2011 Head Start Program Technical/Training account #11-1228; and**

6 **WHEREAS, the Head Start Technical/Training amendment #1 for account 11-1228 has a decrease**  
7 **in line items 650 Tuition and Registration; 655 Lodging; 660 Travel Expense; and**

8 **WHEREAS, the Head Start Technical/Training amendment #1 for account 11-1228 establishes new**  
9 **line item 810 Professional Services in the amount of \$19,000; and**


10 **WHEREAS, the Head Start Technical/Training amendment #1 has been reviewed by the Human**  
11 **Resources Development Committee and the Budget and Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the FY2011 Head Start Program Technical/Training amendment #1 account**  
14 **11-1228 which establishes a new line items 810 professional services reflected in the**  
15 **budget attached hereto.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
17 **Nation's Official, to wit: the Chairman, Vice Chairman, and any designated official are**  
18 **authorized to negotiate and expend the budget, provided however, that any**  
19 **amendments affecting the funds or funding levels of the budget shall be submitted for**  
20 **further prior approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>th</sup> Day**  
22 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**  
24 **(d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
