

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Appropriation for Gaming Office Budget Amendment/Modification No 2**  
**in the amount of \$10,096.00 for FY 2011)**

RESOLUTION NO. 11-302

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY 2011 Gaming Office Budget  
2 pursuant to Legislative Council Resolution No. 10-295; and

3 WHEREAS, the Tohono O'odham Legislative Council approved the Gaming Office FY 2011 Budget  
4 Amendment No. 1 pursuant to Resolution No. 11-101; and

5 WHEREAS, the FY2011 Gaming Office hereby increasing the budget by \$10,096.00 from  
6 \$4,617,571.26 to \$4,627,667.26 as a onetime appropriation to purchase hardware  
7 device for the purpose of verification of all gaming software that requires lab testing  
8 pursuant to the Tribal-State Gaming Compact; and

9 WHEREAS, FY2011 Gaming Office Budget Amendment/Modification No. 2 has been reviewed and  
10 approved by Commerce Committee and the Budget and Finance Committee.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
12 appropriates \$10,096.00 from the general surplus fund as onetime appropriation and  
13 approves the Gaming Office Budget Amendment/Modification No. 2 attached hereto  
14 adjusting the total budget of \$4,617,571.26 to \$4,627,667.26.

15 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
16 Chairperson and any designated official to expend and administer the budget as  
17 attached, provided that any amendments affecting the funds or funding level shall be  
18 submitted for further prior approval by the Tohono O'odham Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>th</sup> Day  
20 of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;  
21 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section  
22 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
25 Stat. 984).
