

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2012 Projected Revenues to the Nation in the Amount of \$72,987,256.74)**

**RESOLUTION NO. 11-309**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**  
2 **funds within the exclusive control of the Tohono O'odham Nation" (Constitution of the**  
3 **Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Legislative Budget and Finance Committee and the Executive Office reviewed the**  
5 **revenue projections and available revenue for FY 2012; and**

6 **WHEREAS, pursuant to Tohono O'odham Legislative Council Resolution No. 09-267, the Nation**  
7 **established a minimum General Fund Surplus Reserve of \$17,219,789.00 an amount**  
8 **equal to 25% of the projected FY2010 General Fund budget; and**

9 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 09-267 provides for the Legislative**  
10 **Council to appropriate funds from the General Fund Surplus Reserve to address**  
11 **shortfall in funds available from the Nation's approved operating budgets; and**

12 **WHEREAS, the Nation's Treasurer has calculated that \$7,329,172.00 is needed from the General**  
13 **Fund Surplus Reserve to fund the Nation's FY 2012 General Fund Budget; and**

14 **WHEREAS, the Legislative Budget and Finance Committee and the Executive Office recommend**  
15 **the adoption of the FY 2012 revenue projections in the amount of \$72,987,256.74 to**  
16 **fund the Nation's General Fund budgets for FY 2012 including \$7,329,172.00 from the**  
17 **General Fund Surplus Reserve established in FY2010 and \$5,627,095.01 from General**  
18 **Fund Surplus and \$7,983,635.60 from Desert Diamond Savings.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
20 **approves FY 2012 projected revenues in the amount of \$72,987,256.74 including**  
21 **\$7,329,172.00 from the General Fund Surplus Reserve established in FY2010 and**  
22 **\$5,627,095.01 from General Fund Surplus and \$7,983,635.60 from Desert Diamond**  
23 **Savings for the purpose of funding the FY 2012 General Fund budgets of the Tohono**  
24 **O'odham Nation.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>th</sup> Day**  
26 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 1,975.25 FOR; 578.65**  
27 **AGAINST; 226.70[02] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**  
28 **by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
