

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2010 Carry Over Budget Department of Justice Bureau of
Justice Assistance Bulletproof Vest Partnership Grant budget in the amount
of \$1,403.14)**

RESOLUTION NO. 11-313

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has received and accepted**
2 **from the Department of Justice (DOJ) Bureau of Assistance (BJA) FY 2009 Bulletproof**
3 **Vest Partnership (BVP) Grant in the amount of \$2,513.12; and**

4 **WHEREAS, there was a remaining balance of unspent funds of \$16,986.88 for a total budget**
5 **approval of \$19,500.00 under Resolution No. 09-589; and**

6 **WHEREAS, funds were spent during the FY 2010 budget year with a remaining balance of**
7 **\$1,403.14; and**

8 **WHEREAS, the TONPD has created a 2011 budget to spend the remaining funds under the BVP**
9 **Grant that allows expenditure up to September 30, 2011; and**

10 **WHEREAS, this grant requires a 50/50 match contribution that has been identified under the 638**
11 **Law Enforcement budgets for matching of \$1,403.14; and**

12 **WHEREAS, these funds may be used for the National Institute of Justice (NIJ) compliant armored**
13 **vests; and**

14 **WHEREAS, this grant does not require Indirect Cost; and**

15 **WHEREAS, this budget has been reviewed by the Budget Office, the Grants & Contracts Office, the**
16 **Executive Office, and the Legislative Domestic Affairs and Budget & Finance**
17 **Committees, all of which recommend approval by the Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
19 **approves and authorizes the implementation of expenditure of this grant awarded in**
20 **FY 2009 and carried over in FY 2010 and 2011 BVP in the amount of \$1,403.14 with a**
21 **50% match Contribution to be pulled from the 638 Law Enforcement budget at cost of**
22 **\$1,403.14 for total budget of \$2,806.28.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19th Day**
28 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
30 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


