

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to FY 2011 Economic Development Budget)**

RESOLUTION NO. 11-315

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**
2 **control of the Tohono O’odham Nation...and to appropriate these funds for the benefit**
3 **of the nation and its members” provided that “(a)ll expenditures of these funds shall**
4 **be pursuant to appropriations or budgets” authorized by resolution or ordinance**
5 **(Constitution of the Tohono O’odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Council appointed a delegation (“Nation’s Delegation”) to explore**
7 **economic development projects; and**

8 **WHEREAS, by Resolution No. 10-295, the Legislative Council passed an Economic Development**
9 **Budget as part of the Executive Branch Fiscal Year 2011 Tribal Budget, provided that**
10 **“any amendments affecting the aggregate total of the funds originally budgeted for the**
11 **purposes for which the funds were budgeted shall be submitted for prior approval by**
12 **the Tohono O’odham Legislative Council”; and**

13 **WHEREAS, the Legislative Council has been briefed on additional actions that are necessary to**
14 **promote economic development and has developed Amendment No. 1 to the Economic**
15 **Development Budget, which is incorporated by this reference, for that purpose.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby**
17 **appropriates \$1,200,000.00 from the General Fund Surplus for Amendment No. 1 to the**
18 **Economic Development Budget for one time funding which is hereby approved;**
19 **provided**

- 20 **1. The Nation’s Chairman is authorized to administer the Economic Development**
21 **Budget in consultation with the other members of the Nation’s Delegation.**
22 **2. Any amendments affecting the funding or funding levels of the Economic**
23 **Development Budget, as amended by Amendment No. 1, shall be submitted for**
24 **prior approval by the Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 19th Day**
26 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,564.80 FOR; -0- AGAINST;**
27 **215.80[01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
28 **1 (d)(2) of Article VI of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**
29 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
