(Approving Amendment No. 1 to Attorney Contract with the Law Firm of Wilmer  
Cutler Pickering Hale and Dorr, LLP, for FY 2011)**

RESOLUTION NO. 11-316

1 **WHEREAS, by Resolution No. 10-420 the Nation approved an Attorney Contract in the amount of**  
2 **\$1,200,000 with the law firm of Wilmer Cutler Pickering Hale and Dorr, LLP, funded by**  
3 **the Economic Development Budget for FY 2011; and**

4 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**  
5 **Contract, which increases the budget for the Attorney Contract by \$950,000, to a new**  
6 **total of \$2,150,000; and**


7 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment**  
8 **No. 1 to the Attorney Contract and recommend approval by the Legislative Council.**

9 **NOW, THEREFORE, BE IT RESOLVED that:**

- 10 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the**  
11 **Attorney Contract with the law firm of Wilmer Cutler Pickering Hale and Dorr, LLP,**  
12 **for FY 2011, which increases the budget for the Attorney Contract by \$950,000, to a**  
13 **new total of \$2,150,000, substantially in the form attached hereto.**
- 14 **2. The Chairperson of the Nation is authorized and directed to execute Amendment**  
15 **No. 1 to the Attorney Contract with the law firm of Wilmer Cutler Pickering Hale and**  
16 **Dorr, LLP.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>th</sup> Day**  
18 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**  
20 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




