

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to Attorney Contract with the Law Firm of Gammage and Burnham, P.L.C. for FY2011)**

RESOLUTION NO. 11-318

1 WHEREAS, by Resolution No. 10-423 the Nation approved an Attorney Contract in the amount of  
2 \$100,000 with the law firm of Gammage and Burnham, P.L.C., funded by the Economic  
3 Development Budget for FY2011; and

4 WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney  
5 Contract, which decreases the budget for the Attorney Contract by \$40,000, to a new  
6 total of \$60,000; and

7 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment  
8 No. 1 to the Attorney Contract and recommend approval by the Legislative Council.


9 NOW, THEREFORE, BE IT RESOLVED that:

10 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the  
11 Attorney Contract with the law firm of Gammage and Burnham, P.L.C. for FY2011,  
12 which decreases the budget for the Attorney Contract by \$40,000, substantially in  
13 the form attached hereto.

14 2. The Chairperson of the Nation is authorized and directed to execute Amendment  
15 No. 1 to the Attorney Contract with the law firm of Gammage and Burnham, P.L.C.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>th</sup> Day  
17 of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;  
18 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of  
19 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
20 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
21 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
