

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating and Approving Legislative Branch FY 2012 Budget in the amount
of \$3,194,918.12)

RESOLUTION NO. 11-321

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority "to manage any funds within the exclusive control of the Tohono O'odham**
3 **Nation. . . and to appropriate these funds for the benefit of the Nation and its**
4 **members" "provided that" [a]ll expenditures of these funds shall be pursuant to**
5 **appropriations or budgets" authorized by resolution or ordinance (Constitution of the**
6 **Tohono O'odham Nation, Article VI, section 1(d)(2)); and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY2012**
8 **Legislative Branch Budget, which is incorporated herein by this reference; and**


9 **WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY**
10 **2012 Legislative Branch Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **and authorizes expenditure of the FY 2012 Legislative Branch Budget in the amount**
13 **of \$3,194,918.86, per the attached budget, beginning October 1, 2011 and ending**
14 **September 30, 2012.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council does hereby authorize the**
16 **Legislative Chairperson and any designated official to expend and administer the**
17 **budget as attached, provided that any amendments affecting the funds or funding**
18 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
21 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and 226.70[03] ABSENT, pursuant to the powers vested in the Council by Section**
23 **1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**




