

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2012 Budget for the Tohono O'odham Nation Justice
Center and Appropriating Funds in the Amount of \$5,674,993.72)

RESOLUTION NO. 11-322

1 WHEREAS, the Fiscal Year ("FY") 2011 will end at midnight, September 30, 2011 and all spending
2 authority granted under the FY 2011 budgets will terminate at that time; and

3 WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and presented a
4 budget to the Tohono O'odham Legislative Council ("Legislative Council") that reflects
5 the needs of the Branch for the 2012 fiscal year, a copy of the proposed said budget is
6 attached hereto and incorporated herein by reference; and

7 WHEREAS, the proposed FY 2012 Judicial Branch budget includes employee salaries in the
8 amount of \$3,736,018.44, other compensation at \$159,919.62, fringe benefits at 32.5%
9 in the amount of \$1,266,179.87, and operational costs in the amount of \$512,875.79,
10 totaling \$5,674,993.72 for FY 2012; and

11 WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative
12 Council have reviewed this budget and recommend its approval and adoption.

13 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and
14 approves the Fiscal Year 2012 budget for the Tohono O'odham Judicial Branch in the
15 amount of \$5,674,993.72.

16 BE IT FURTHER RESOLVED that funds in the amount of \$5,674,993.72 is appropriated from the
17 general funds and authorized to be expended for the Fiscal Year 2012 budget of the
18 Tohono O'odham Judicial Branch.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20 Chief Judge and any designated official to expand and administer the Budget as
21 attached, provided that any Amendments affecting the funds or funding level is
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day
24 of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
25 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1
26 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
27 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).


