1 **WHEREAS, the Water Resources Department is requesting \$1,867,081.72 from the Southern**
2 **Arizona Water Rights Settlement Act Trust Fund for the FY2012 budget 21-1525; and**

3 **WHEREAS, the Water Resources Department is also requesting an in-kind service match of**
4 **\$7,368.00 from the FY2012 budget 21-1525 for the Water Resources Department FY2012**
5 **budget 11-5017; and**

6 **WHEREAS, the Water Resources Department FY2012 budget 21-1525 has been reviewed by the**
7 **Legislative Water Resources Committee and the Budget and Finance Committee.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
9 **authorizes:**

- 10 **1. The appropriation and expenditure of \$1,867,081.72 from the Southern Arizona**
11 **Water Rights Settlement Act Trust Fund for the Water Resources Department**
12 **FY2012 budget 21-1525, in accordance with the budget attached hereto.**
13 **2. An in-kind service match of \$7,368.00 from the FY2012 budget 21-1525 to the Water**
14 **Resources Department FY2012 budget 11-5017.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairperson and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding levels of the**
18 **budget shall be submitted for further prior approval by the Tohono O'odham**
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
21 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)(j)**
23 **of Article VI and XVII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
