

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Tribal Employment Rights Commission TERO**  
**Fee Budget #44-1071 at \$319,875.35 for FY 2012)**

**RESOLUTION NO. 11-329**

1 **WHEREAS, the Tohono O'odham Nation adopted the Employment Rights Ordinance No. 01-85**  
2 **which established the Tribal Employment Rights Commission, who was charged with**  
3 **carrying out the terms of the Ordinance; and**

4 **WHEREAS, the independent Commission functions in the applications of preference in**  
5 **contracting and employment under the TERO Ordinance No. 01-85; as amended, 13**  
6 **T.O.C. Chapter 1; and**

7 **WHEREAS, the Tribal Employment Rights Commission is assisted by the Tribal Employment**  
8 **Rights Office, which has operated since 1978; and**

9 **WHEREAS, the Employment Rights Ordinance provides, in Section 11 for the collection of**  
10 **Employment Rights TERO Fees from all covered employers operating within the**  
11 **exterior boundaries of the Nation; and**

12 **WHEREAS, the purpose of the TERO Fees is to raise revenue for the operation of the Tribal**  
13 **Employment Rights Commission; and**

14 **WHEREAS, in accordance with Section 11 (C) of the Ordinance, the TERO fees collected shall be**  
15 **expended by the Tribal Employment Rights Commission pursuant to budgets duly**  
16 **approved by the Executive Office and Legislative Council to carry out the purposes of**  
17 **the Ordinance, including training programs for workers and business persons; and**

18 **WHEREAS, the Tribal Employment Rights Commission submits FY 2012 budget in the amount of**  
19 **\$319,875.35 from the remaining TERO fees collected; and**

20 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**  
21 **Legislative Council have reviewed this Budget and recommend its approval and**  
22 **adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
24 **approves the Tribal Employment Rights Commission FY 2012 Budget in the amount**  
25 **of \$319,875.35 for a grand total of \$319,875.35 attached hereto.**

26 **BE IT FURTHER RESOLVED that any remaining TERO fee balance shall be carried over to the next**  
27 **fiscal year of 2013.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorize**  
29 **the Tribal Employment Rights Commission and any designated official to expend and**  
30 **administer the budget as attached, provided that any amendments affecting funds or**


