

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance - FY2012 Food Distribution Program Budget - Account No. 11-1315)**

RESOLUTION NO. 11-330

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2011 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**
5 **Nation and the people; and**

6 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2012 United**
7 **States Department of Agriculture funds to assist eligible individuals and families with**
8 **commodity foods; and**

9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
10 **Division, Food Distribution Program has submitted for review and approval, the**
11 **proposal and budget in the amount of \$192,139.08; and**

12 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
13 **of the Legislative Council have reviewed this Budget and recommend its approval and**
14 **adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the FY 2012 Budget in the amount \$192,139.08 and to utilize the Nations Resources**
17 **pending reimbursement from the Grantor for the continuation of the Food**
18 **Distribution Program.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall be**
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
24 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
25 **-01- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**
26 **(d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**




