

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance – FY2012 Food Distribution Program Nutrition Education Funding Budget Account No. 11-1316)**

RESOLUTION NO. 11-331

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2011 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**
5 **(commodity foods) and nutrition education to eligible households through tailgate**
6 **runs throughout the Nation and nearby towns;**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation**
8 **for FY2012 through the USDA in the amount of \$1,800.00; and**

9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
10 **Division, Food Distribution Program has submitted the FY2012 Nutrition Education**
11 **funding budget in the amount of \$1,800.00 for review and approval; and**

12 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
13 **of the Legislative Council have reviewed this Budget and recommend its approval and**
14 **adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the FY2012 Food Distribution Nutrition Education budget in the amount of \$1,800.00**
17 **and to utilize the Nations Resources pending reimbursement from the Grantor for the**
18 **continuation of the Food Distribution Program.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall be**
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
24 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1**
26 **(d)(2)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
