RESOLUTION NO. 11-333

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Program for Indians grant**
2 **through FY 2012 with a base budget of \$1,929,827.00; and**

3 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Program for Indians, authorized by the Balanced Budget Act of 1997;**
6 **and**

7 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**
8 **the name change of the Community Based Diabetes Prevention Program to the**
9 **Healthy O'odham Promotion Program; and**

10 **WHEREAS, the Tohono O'odham Department of Health & Human Services Division of Health**
11 **Promotion is seeking approval of the FY 2012 budget of \$1,929,827.00 per resolution;**
12 **and**

13 **WHEREAS, the Executive Office, the Health and Human Service Oversight Committee and the**
14 **Budget & Finance Committee has reviewed and approved this budget.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **the FY 2012 Budget in the amount of \$1,929,827.00; and to utilize the Nations**
17 **Resources pending reimbursement from the Grantor for the continuation of the Grant**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the Budget as**
20 **attached, provided that any Amendments affecting the funds or funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day**
23 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
25 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
26 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
27 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
