

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Child
Welfare Services, FY 2012 Child Welfare Division Revenue Budget for client
support needs with fundraising and donation funds, Account No. 44-1444)**

RESOLUTION NO. 11-337

1 **WHEREAS, the Tohono O'odham Nation's (Nation) Child Welfare Division, under the supervision**
2 **of the Department of Health and Human Services, with funds authorized and**
3 **appropriated by the Nation, conducts events for the children in the care and custody**
4 **of Child Welfare; such as an annual Christmas party, Culture Day, Spring activity and**
5 **related events; and**

6 **WHEREAS, the Child Welfare Division has solicited donations and has operated other fundraising**
7 **in order to supplement funds budgeted for the Division of Child Welfare Services and**
8 **related events; and**

9 **WHEREAS, by Resolution No. 06-771, the Tohono O'odham Legislative Council authorized the**
10 **creation of an account for the Nations Department of Health and Human Services,**
11 **Division of Child Welfare Services to use, receive and expend any and all funds from**
12 **sponsors, donors, sales and fundraising, to supplement funds allocated by the Nation;**
13 **and**

14 **WHEREAS, the Executive Branch developed and obtained committee approval of FY 2012 Child**
15 **Welfare Division Revenue Budget attached and incorporated by this reference, to be**
16 **effective October 1, 2011 through September 30, 2012 and requests authorization to**
17 **expend funds over the fiscal year of FY 2012 estimated at \$10,000.00, based on**
18 **historical donations and fundraising; and**

19 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
20 **of the Legislative Council have reviewed this Budget and recommend its approval and**
21 **adoption.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
23 **approves and authorizes the Executive Branch to expend funds for the budget**
24 **attached, effective October 1, 2011 through September 30, 2012 and requests**
25 **authorization to expend funds for FY 2012 totaling \$10,000.00, estimated to be funded**
26 **by donations and fundraising.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the FY**
28 **2012 Budget in the amount of \$10,000.00 and to utilize the Nations Resources to be**
29 **reimbursed based on actual donations and contributions for the continuation of Child**
30 **Welfare Services.**



3 attached, provided that any budget amendments affecting the funds or funding levels
4 shall be submitted for further prior approval by the Tohono O'odham Legislative
5 Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st Day
7 of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
8 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)
9 of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
10 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
11 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
