

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2012 Department of Health and Human Services-Division of**  
**Health Transportation Service Third Party Revenue Budget)**

RESOLUTION NO. 11-339

1 **WHEREAS, the Tohono O'odham Nation continues to provide non-emergency medically necessary**  
2 **transportation to members and residents of the Nation, and collecting third party**  
3 **reimbursements where applicable; and**

4 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 04-639 authorized all third**  
5 **party reimbursement funds collected by the Division of Health Transportation Service**  
6 **to supplement the Division's base budget for operations; and**

7 **WHEREAS, there is a need to supplement the FY 2012 tribal budget with FY 2010 Third Party**  
8 **Revenue funds for operational costs to pay for purchase of vehicles, pay for additional**  
9 **staff to supplement permanent staff under the base budget, pay for training, pay for**  
10 **vehicle maintenance and major vehicle repair costs, and supplement gas, oil and**  
11 **coolant expenses; and**

12 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
13 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
14 **adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 16 **1. Approves the attached FY 2012 Third Party Revenue Budget in the amount of**  
17 **\$2,555,216.00 to supplement the FY 2012 Health Transportation Service budget.**
- 18 **2. Authorizes that all Third Party revenue funds shall be utilized to supplement the**  
19 **Health Transportation Service Tribal budgets.**
- 20 **3. Authorizes Health Transportation to expend the funds in the dedicated revenue**  
21 **account for personnel, operational and major capital purchases and expenditures**  
22 **consistent with approved Health Transportation Service budgets.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the Budget as**  
25 **attached, provided that any Amendments affecting the funds or funding level is**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>st</sup> Day**  
28 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**  
30 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**




