

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval and Acceptance of the Application of the FY 2012 Grant Award USEPA
General Assistance Program (GAP))**

RESOLUTION NO. 11-344

1 **WHEREAS, Tohono O'odham Legislative Council accepted \$335,867.00 in new funding for the**
2 **continuation of the General Assistance Program (GAP) by Resolution No. 10-1301; and**

3 **WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that extends from**
4 **August 1, 2009 through September 30, 2013 which requires annual applications for**
5 **new funding; and**

6 **WHEREAS, the Tohono O'odham Nation submitted a proposal to the US EPA Region 9 in the**
7 **amount of \$335,867.00 for the General Assistance Program for FY2012 which will be**
8 **awarded in Assistance Agreement; and**


9 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee of the**
10 **Legislative Council have reviewed this Budget and recommend its approval and**
11 **adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
13 **and approves the FY 2012 proposal in the amount of \$335,867.00 and to utilize the**
14 **Nations Resources pending reimbursement from the Grantor for the continuation of**
15 **the grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
21 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
23 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
