

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2012 Budget for the Tohono O'odham Nation Vocational
Rehabilitation Program, Grant Award H250D080009)

RESOLUTION NO. 11-349

1 **WHEREAS, the Tohono O'odham Nation, upon enactment of Resolution No. 08-614, accepted a 5-**
2 **year grant, beginning October 1, 2008 to September 30, 2013, from the U.S. Department**
3 **of Education, Rehabilitation Services Administration's Section 121 (Vocational**
4 **Rehabilitation Service Projects for American Indian with Disabilities) under P.L., 102-**
5 **569 Rehabilitation Act of 1973 as amended; and**

6 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**
7 **be provided to eligible enrolled members of the Tohono O'odham Nation living on or**
8 **near the Nation and other federally recognized American Indians living on the Nation**
9 **with disabilities; and**

10 **WHEREAS, the Tohono O'odham Nation will contribute the required 10% match from the**
11 **Department of Education Administration budget and the General Cost Pool; and**

12 **WHEREAS, the Vocational Rehabilitation Program has developed the FY 2012 budget in amount**
13 **of \$443,242.00 beginning October 1, 2011 through September 30, 2012 and is seeking**
14 **approval of the attached budget.**

15 **WHEREAS, Human Resources Development Committee and the Budget and Finance Committee**
16 **of the Legislative Council have reviewed this Budget and recommend its approval and**
17 **adoption.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
19 **and approves the Vocational Rehabilitation Program's FY 2012 proposal and will**
20 **contribute the required 10% match in the amount of \$443,242.00 and to utilize the**
21 **Nations Resources, pending reimbursement from the Grantor for the continuation of**
22 **the grant.**

23 **BE IT FURTHER RESOLVED that the Council approves the attached budget and authorizes the**
24 **expenditure of funds according to this budget, which shall be in effect from October**
25 **1, 2011 to September 30, 2012.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Chairperson and any designated official to expend and administer the budget as**
28 **attached, provided that any amendments affecting the funds or funding level shall be**
29 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
31 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
32 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
33 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
34 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
35 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
