

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2012 Arizona Reimbursable Budget: Child and Food Program)**

RESOLUTION NO. 11-350

1 **WHEREAS, the Tohono O'odham Nation has historically sought reimbursement through an**
2 **agreement from the State of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food Program**
4 **Service Agreement provided reimbursement of funds for food costs incurred based on**
5 **the guidelines identified in the agreements; and**

6 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
7 **Committee of the Legislative Council have reviewed this Budget and recommend its**
8 **approval and adoption.**

9 **1. Child and Adult Care Food Program - \$73,000.00 + \$12,278.60 (IDC)= \$85,278.60**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the Child and Food Care Program is authorized to expend funds for the program listed**
12 **herein, effective October 1, 2011 through September 30, 2012.**


13 **1. Child and Food Care Food Program - \$73,000.00 + \$12,278.60 (IDC) = \$85,278.60**

14 **BE IT FURTHER RESOLVED that the Executive Branch will seek reimbursement from the Arizona**
15 **Department of Education through the Child and Adult Care Food Program Service**
16 **Agreement, to reimburse funds for food costs incurred based on the guidelines**
17 **identified in the agreement.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the Budget as**
20 **attached, provided that any Amendments affecting the funds or funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
23 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
25 **(d)(2)(3)&(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
