

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division PL 102-477 Indian
Employment Training and Related Services Demonstration Act of 1992
Budget FY2012)

RESOLUTION NO. 11-351

1 **WHEREAS, the PL 102-477 Indian Employment Training and Related Services Demonstration Act**
2 **of 1992 budget administers all combined federal programs under the Education**
3 **Department One Stop Division from October 1, 2011 to September 30, 2012 in the**
4 **combined amount of \$1,062,190.41 with projected allocations; and**

5 **WHEREAS, the 477 budget had been developed and cost shared with the Arizona Department of**
6 **Economic Security funding to promote smooth transitional services for clients with**
7 **an effective cost shared to promote de-centralized services; and**


8 **WHEREAS, the Human Resource Development Committee and Budget and Finance Committee**
9 **of the Legislative Council have reviewed this Budget and recommend its approval and**
10 **adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
12 **approve and authorize the expenditure of the FY 2012 PL 102-477 Budget for the**
13 **Education Department - One Stop Division effective October 1, 2011 to September 30,**
14 **2012 in the projected amount of \$1,062,190.41.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairperson and any designated official to expend and administer the Budget as**
17 **attached, provided that any Amendments affecting the funds or funding level is**
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
20 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
22 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**




