

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2012 Department of Health and Human Services Child Care and  
Development Fund Budgets)**

**RESOLUTION NO. 11-352**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child Care**  
4 **Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Child Care Services prepared the following FY 2012 Child Care and Development**  
6 **Fund (CCDF) Budgets and requests authorization to expend funds in the amount of**  
7 **\$1,034.425:**

8 **1. FY 2012 CCDF Mandatory Funds - \$582,552.73 + \$67,070.27 (IDC) = \$649,623.00.**

9 **2. FY 2012 CCDF Discretionary Funds - \$334,806.95 + \$49,995.05 (IDC) = \$384,802.00.**

10 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**  
11 **Committee of the Legislative Council have reviewed this Budget and recommend its**  
12 **approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
14 **and approves the FY 2012 Budgets in the amount of \$1,034.425 and to utilize the**  
15 **Nations Resources pending reimbursement from the Grantor for the continuation of**  
16 **the Child Care Services :**

17 **1. FY 2012 CCDF Mandatory Funds - \$582,552.73 + \$67,070.27 (IDC) = \$649,623.00.**

18 **2. FY 2012 CCDF Discretionary Funds - \$334,806.95 + \$49,995.05 (IDC) = \$384,802.00.**

19 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for**  
20 **the program listed herein above and as attached in the amounts indicated, effective**  
21 **October 1, 2011 through September 30, 2012 for the FY 2012 Child Care and**  
22 **Development Fund Budgets:**

23 **1. FY 2012 CCDF Mandatory Funds - \$582,552.73 + \$67,070.27 (IDC) = \$649,623.00.**

24 **2. FY 2012 CCDF Discretionary Funds - \$334,806.95 + \$49,995.05 (IDC) = \$384,802.00.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the Budget as**  
27 **attached, provided that any Amendments affecting the funds or funding level is**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>nd</sup> Day**  
30 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
31 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**  
32 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
35 **Stat. 984).**


