

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to expend program revenue in the amount of \$350,000.00 for the Solid Waste Management Program FY2012 budget 83-0003 and approve the deposit of the program revenue to the Bank of America Solid Waste Revenue Account)**

RESOLUTION NO. 11-353

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**
2 **Waste Management Program budget 83-0003 through Resolution 98-236 and 05-558;**
3 **and**

4 **WHEREAS, the Solid Waste Management Program has generated on an annual average at least**
5 **\$350,000.00 in program revenue from residential and commercial trash collection,**
6 **heavy equipment services and the sale of recycling materials; and**

7 **WHEREAS, the Solid Waste Management Program has prepared a budget amount of \$350,000.00**
8 **for the FY2012 budget 83-0003; and**

9 **WHEREAS, the Solid Waste Management Program budget 83-0003 has been reviewed and**
10 **approved by the Legislative Natural Resources Committee and the Legislative Budget**
11 **and Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council: authorizes**
13 **the expenditure of \$350,000.00 for the Solid Waste Management Program FY2012**
14 **budget 83-0003, from October 1, 2011 through September 30, 2012, in accordance with**
15 **the budget attached hereto.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the Budget as**
18 **attached, provided that any Amendments affecting the funds or funding level is**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
21 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**
23 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
