1 **WHEREAS, at a special session of the Tohono O'odham Legislative Council held in July, 2011; and**  
2 **WHEREAS, Baboquivari district representatives presented budget amendment #3 for Choulic**  
3 **community FY 2011 budget for review and approval; and**

4 **WHEREAS, the budget amendment #3 will be applied to the line item 861.00 Miscellaneous**

7 **WHEREAS, this amendment will increase the Choulic Community FY 2011 budget of \$185,592.28**  
8 **to a revised amount of \$186,052.28; and will also increase the overall District's FY 2011**  
9 **budget of \$1,720,922.80 to a revised amount of \$1,721,382.80.**


10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
11 **budget amendment #3 in the amount of \$460.00 from gravel sales to the Tohono**  
12 **O'odham Nation Planning Department and incorporating it into the FY 2011 Choulic**  
13 **Community budget.**

14 **BE IT FURTHER RESOLVED that this budget amendment #3 will affect the Choulic community's**  
15 **current FY 2011 budget of \$185,592.28 to a revised amount of \$186,052.28, and will**  
16 **affect the overall Baboquivari District's current FY 2011 budget of \$1,720,922.80 to a**  
17 **revised amount of \$1,721,382.80.**

18 **BE IT FINALLY RESOLVED that any modifications, amendments, or changes in the justifications**  
19 **shall be reviewed and approved by the Budget & Finance Committee and the Tohono**  
20 **O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>nd</sup> Day**  
22 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**  
24 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
