(Approving the Gu Achi District FY 2011 Budget Amendment #2 for Palo Verde Community)

RESOLUTION NO. 11-356

1 WHEREAS, the Tohono O'odham Legislative Council did convene on July 22, 2011 to address issues
2 pertaining to the Nation; and

3 WHEREAS, on July 16, 2011 at a special District meeting, the Gu Achi District Council approved
4 Budget Amendment #2 for Palo Verde Stand Community (Resolution #1107-032); and

5 WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review
6 the community budget amendment submitted by the Gu Achi District and recommend
7 approval.


8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
9 approve the Gu Achi District FY 2011 Budget Amendment #2 for Palo Verde Stand Community.

10 BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming
11 Distribution of \$1,705,922.80 to the Gu Achi District.

12 BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day
14 of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
15 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1
16 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
17 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
19 Stat. 984).


