

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif-Oidak District FY 2011 Home Repair/Renovation Budget Amendment #1)**

RESOLUTION NO. 11-357

1 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. 11-132, "Approving the Sif-Oidak**
2 **District FY 2011 Home Repair/Renovation Budget Amendment #1; and**

3 **WHEREAS, amendment #1 reflects additional language to the justification in Line Items: (727)**
4 **Materials, to include "building materials for new home construction" and to reduce**
5 **the number by one (1), for approximately (22) homes and (751) Lease and Rentals, to**
6 **include "storage bin rentals, apartment leases"; and**

7 **WHEREAS, the Amendment allows the District to construct new homes for the District members.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
9 **approve the Sif-Oidak District FY 2011 Home Repair/Renovation Budget Amendment**
10 **#1 to include additional language to the following line items:**

11 **727 - Materials: to include building materials for new home construction for**
12 **approximately (22) homes.**


13 **751 - Lease & Rentals: to include storage bin rentals, apartment leases.**

14 **BE IT FURTHER RESOLVED that the Amendment #1 does not reflect any changes to the budget**
15 **amount.**

16 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding**
17 **levels that it shall be approved b the Tohono O'odham Legislative Council prior to any**
18 **expenditures.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
20 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1**
22 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
