1 **WHEREAS, the Sif-Oidak District Council, passed Resolution No. 11-133, "Approving the FY 2011**
2 **Sif-Oidak District Administration Budget Modification/Amendment #1; and**

3 **WHEREAS, modification/amendment #1 is transferring funds between line items in the amount**
4 **of \$27,289.75; specifically decreasing Line items 618 - Contingency by \$4,816.30; 625 -**
5 **Education Supplement by \$5,000.00; 750 - Major Capital by \$17,473.45 and increasing**
6 **Line items 610 - Casual Labor by \$10,000.00; 660 - Travel Expense by \$2,000.00; 710 -**
7 **Utilities by \$4,500.00; 712 - Gas, Oil, & Coolants by \$2,500.00; 751 - Lease and Rentals by**
8 **\$6,500.00; 770 - R&M Other by \$500.00; 771 - R&M Vehicles by \$1,289.75.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
10 **approve the FY 2011 Sif-Oidak District Administration Budget Modification**
11 **/Amendment #1.**

12 **BE IT FURTHER RESOLVED that the Modification/Amendment #1 is transferring funds between**
13 **line items in the amount of \$27,289.75; specifically decreasing Line items 618 -**
14 **Contingency by \$4,816.30; 625 - Education Supplement by \$5,000.00; 750 - Major**
15 **Capital by \$17,473.45 and increasing Line items 610 - Casual Labor by \$10,000.00; 660 -**
16 **Travel Expense by \$2,000.00; 710 - Utilities by \$4,500.00; 712 - Gas, Oil, & Coolants by**
17 **\$2,500.00; 751 - Lease and Rentals by \$6,500.00; 770 - R&M Other by \$500.00; 771 - R&M**
18 **Vehicles by \$1,289.75.**

19 **BE IT FURTHER RESOLVED that the Modification/Amendment #1 does not reflect any changes to**
20 **the budget amount.**

21 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding of funding**
22 **levels that it shall be approved by the Tohono O'odham Legislative Council prior to any**
23 **expenditures.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
25 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**

27 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
