

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving the S-tuha Bidag Community FY2011 Budget Amendment No. 1)

RESOLUTION NO. 11-359

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 10-290 appropriated the**
2 **FY2011 Gaming Distribution Funds to the 11 Districts of the Tohono O'odham Nation;**
3 **and**

4 **WHEREAS, the Legislative Council appropriated \$1,757,919.88 to the Hikiwan District for FY2011;**
5 **and**

6 **WHEREAS, the Hikiwan District Council after review and acceptance by the seven communities**
7 **of the District, enacted Resolution No. HDC-10-050 appropriated the amount of**
8 **\$1,498,919.88 to the FY2011 Budget for Hikiwan District Administration; and**

9 **WHEREAS, the Hikiwan District Council by Resolution No. HDC-10-051 accepted and approved the**
10 **FY2011 Budgets for the following communities: Gehakah, Ventana, Vaya Chin, S-tuha**
11 **Bidag, South Hikiwan, Hodai Son Wo'o, and Schuchuligk in the amount of \$37,000 for**
12 **each community for a total of \$222,000.00; and**

13 **WHEREAS, by Resolution No. HDC-11-034, the Hikiwan District Council approved the FY2011**
14 **Budget Amendment #01 submitted by the S-tuha Bidag Community to amend its**
15 **Budget to zero out Line Item 612-Occasional Appointments and Line Item 620-Fringe**
16 **Benefits Total Amount \$6,860.91; and**

17 **WHEREAS, the Hikiwan District hereby requests approval of the attached FY2011 Budget**
18 **Amendment #01 for the S-tuha Bidag Community.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
20 **accepts and approves the FY2011 Budget Amendment #01 for S-tuha Bidag**
21 **Community, as attached.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached; provided that any amendments affecting the funds of funding level shall be**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22nd Day**
27 **of JULY, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
28 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1**
29 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**


