

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving to Add 1 Eligible Adult Member to the Master List for Payment of the
Third Per Capita, Certifying the 1 Eligible Adult Member and Authorizing
Distribution to the Certified Member)**

RESOLUTION NO. 11-372

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" (the "Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation, was subsequently amended to authorize per capita distribution payments in**
7 **accordance with the Initiative (Legislative Council Resolution No. 97-303); and**

8 **WHEREAS, the Legislative Council adopted the Third Per Capita Plan per Legislative Council**
9 **Resolution No. 06-307; and**

10 **WHEREAS, the Secretary of the Department of the Interior approved the Third Per Capita**
11 **Revenue Allocation plan on July 28, 2006; and**

12 **WHEREAS, the Enrollment Program has identified 1 eligible adult member who was left off the**
13 **Third Adult Master List previously approved by the Legislative Council; and**

14 **WHEREAS, pursuant to Resolution No. 06-624 the Legislative Council approved the Third Master**
15 **Listing for Eligible Adult members; and**

16 **WHEREAS, the disbursement of funds to each eligible member is contingent upon verification of**
17 **a member and further certification by the Tohono O'odham Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 19 **1. Accepts and approves the addition of 01 eligible adult member to the Third Adult**
20 **Master List for the Third Per Capita payment.**
- 21 **2. Certifies the 01 eligible adult member for the Third Per Capita payment.**
- 22 **3. Authorizes (a) transfer of \$2,000.00 from the Third Per Capita Money Market**
23 **Account to the Third Per Capita Checking Account established at Bank of America;**
24 **and (b) upon the authorized signature of the Nation, issuance of a check on the**
25 **Third Per Capita Checking Account in the amount of \$2,000.00 to the 1 eligible**
26 **adult member.**
- 27 **4. Authorize the Chairman of the Nation to execute such other documents as**
28 **necessary to implement this Resolution.**

1 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of**
2 **funds to each additional eligible adult Tohono O'odham member is contingent upon**
3 **verification of a member by the Enrollment Program and further certification of**
4 **additional eligible members by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
6 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
7 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
8 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
9 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
11 **18, 1934 (48 Stat. 984).**


