

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY2011 Budget Amendment No. 3)

RESOLUTION NO. 11-383

1 **WHEREAS, the Chukut Kuk District Council did meet on May 17, 2011 in San Miguel at which a**
2 **quorum was present; and**

3 **WHEREAS, FY2011 Budget Amendment No. 3 was approved by Chukut Kuk District Council**
4 **resolution no. 2011-30; and**

5 **WHEREAS, the amount of \$15,264.00 will be transferred to line item 610-Salaries to cover the vice**
6 **chairperson position for the period beginning June 13, 2011 and ending September 30,**
7 **2011; and**

8 **WHEREAS, there is sufficient funds in line item 620-Fringe Benefits to cover fringe benefits for the**
9 **vice chairperson position for the period beginning June 13, 2011 to September 30,**
10 **2011; and**

11 **WHEREAS, the Chukut Kuk District FY2011 Budget Amendment No. 3 has been presented to the**
12 **Legislative Council Budget & Finance Committee for review.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **Chukut Kuk District FY2011 Budget Amendment No. 3 attached hereto and**
15 **incorporated herein.**

16 **BE IT FURTHER RESOLVED that the amount of \$15,264.00 will be transferred from line item 780-**
17 **Contingencies to line item 610-Salaries to cover the salary for the vice chairperson**
18 **position for the period beginning June 13, 2011 and ending September 30, 2011.**

19 **BE IT FURTHER RESOLVED that that there is sufficient funds in line item 620-Fringe Benefits to**
20 **cover fringe benefits in the amount of \$2,769.21 for the vice chairperson position for**
21 **the period beginning June 13, 2011 and ending September 30, 2011.**

22 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
23 **District FY2011 budget shall be submitted to the Tohono O'odham Legislative Council**
24 **for prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
26 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.90 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**




