

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY2011 Budget Amendment/Modification No. 4)**

RESOLUTION NO. 11-384

1 **WHEREAS, the Chukut Kuk District Council did meet on June 11, 2011 in San Miguel at which a**
2 **quorum was present; and**

3 **WHEREAS, FY2011 Budget Amendment/Modification No. 4 was approved by Chukut Kuk District**
4 **Council Resolution No. 2011-39; and**

5 **WHEREAS, the amount of \$60,000.00 will be taken from Savings and added to line item 810 -**
6 **Professional Services to cover anticipated costs; and**

7 **WHEREAS, the total amount of \$103,616.20 will be transferred to various line items to cover over**
8 **expenditure of funds and anticipated costs; and**

9 **WHEREAS, Chukut Kuk District FY2011 Budget Amendment No. 4 has been presented to the**
10 **Legislative Council Budget & Finance Committee for review.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **Chukut Kuk District FY2011 Budget Amendment/Modification No. 4 attached hereto**
13 **and incorporated herein.**

14 **BE IT FURTHER RESOLVED that the amount of \$60,000.00 will be taken from Savings and added to**
15 **line item 810 - Professional Services to cover anticipated costs.**

16 **BE IT FURTHER RESOLVED that that the total amount of \$103,616.20 will be transferred to various**
17 **line items to cover over expenditure of funds and anticipated costs.**

18 **\$101,616.20 will be transferred from line item 780 - Contingencies**

19 **\$2,000.00 will be transferred from line item 750 - Capital Equipment**

20 **\$2,000.00 will be added to line item 661 - Mileage**

21 **\$5,117.43 will be added to line item 711 - Communication Expense**

22 **\$69,770.82 will be added to line item 810 - Professional Services**

23 **\$4,549.26 will be added to line item 850 - Food**

24 **\$22,178.69 will be added to line item 865 - Other Emergencies**

25 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
26 **District FY2011 budget shall be submitted to the Tohono O'odham Legislative Council**
27 **for prior approval.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
29 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.90 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat. 984).**


