RESOLUTION NO. 11-386

1 **WHEREAS, the Master 477 budget administers all combined federal programs under the**
2 **Education Department One Stop Division from October 1, 2010 to September 30, 2011,**
3 **in the combined amount of \$1,062,190.41 under Resolution No. 10-328; and**

4 **WHEREAS, the Master 477 budget had been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional services for**
6 **clients; and**

7 **WHEREAS, the Master 477 budget requires an Amendment to reflect the actual allocations in the**
8 **amount of \$1,337,208.00; and**

9 **WHEREAS, the budget Amendment #1 has been prepared to increase line items: #611; #620; #650;**
10 **#655; #660; #711; #712; #720; #721; #770; #771; #856; #900; and**

11 **WHEREAS, establish new line items #772; #812; #860; and**

12 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**
13 **Committee of the Legislative Council have reviewed the Master 477 budget and**
14 **recommend its approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve and authorize the expenditure of the FY 2011 Master 477 Budget for the**
17 **Education Department - One Stop Division effective October 1, 2010 to September 30,**
18 **2011 in the amount of \$1,337,208.00, increasing line items: #611; #620; #650; #655;**
19 **#660; #711; #712; #720; #721; #770; #771; #856; #900; and establishing new line items**
20 **#772; #812; and #860.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget as**
23 **attached, provided that any amendments affecting the funds or funding level is**
24 **submitted the for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
26 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,564.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 215.80[07] ABSENT, pursuant to the powers vested in the Council**
28 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
