Amendment #1 FY 2011 DOL Supplemental Youth Services Budget)

RESOLUTION NO. 11-387

1 WHEREAS, the One Stop Division Bureau of Indian Affairs - 477 Budget FY 2010 budget has been
2 developed as part of the DOL Supplemental Youth Services for Native Americans 2009
3 Recovery Act approved under Resolution No. 09-427; and

4 WHEREAS, a new budget was created and approved under Resolution No. 11-182 in the amount
5 of \$43,425.45 and now request to amend the budget to expend the funds; and

6 WHEREAS, line items #650, 655, and 711 are zeroed out; line item #660 is decreased; line item #712
7 is decreased; line item #856 is increased and line item #900 is decreased; and


8 WHEREAS, the Human Resources Development Committee and the Budget & Finance Committee
9 of the Legislative Council have reviewed this budget and recommend its approval and
10 adoption.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
12 accept, approve, and authorize amendment #1 with a decrease to line item #900 (IDC)
13 and expenditure of the DOL Supplemental Youth Services Budget Contract No.
14 GTK00T142AR, Education Department- One Stop Division Bureau of Indian Affairs-477
15 ARRA Budget FY 2011 of \$43,425.45.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
17 Nation's Officials, to wit; the Chairperson and any official appointed designee is hereby
18 authorized to expend the budget provided however, that any amendment affecting the
19 funding or funding levels of this budget shall be submitted for further prior approval
20 by this Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
22 of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,564.80 FOR; -0-
23 AGAINST; -0- NOT VOTING; and 215.80[06] ABSENT, pursuant to the powers vested in the Council
24 by Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted
25 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).


