

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family**  
**Assistance – FY11 Tribal Food Distribution Program**  
**Budget Amendment #1 - Account No. 01-1315)**

**RESOLUTION NO. 11-390**

1 **WHEREAS, by Resolution Number 10-295, the Tohono O'odham Legislative Council approved the**  
2 **FY2011 Food Distribution Program Tribal budget in the amount of \$78,559.77; and**

3 **WHEREAS, the Nation was notified of the final grant award for the Food Distribution Program**  
4 **USDA budget with an increase in funding which funding requirement is at a 75% match**  
5 **by USDA and a 25% match by tribal funds; and**

6 **WHEREAS, due to the increase in the USDA funding, the Tribal match has decreased from**  
7 **\$78,559.77 to \$67,987.00, a decrease of \$10,572.77; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval for the Department**  
9 **of Health and Human Services, Tribal Food Distribution Program Budget Amendment**  
10 **#1 which decreases line item 610 Salaries; 620 Fringe Benefits; 630 Insurance; 661**  
11 **Mileage POV; 712 gas, oil and coolants; 770 R/M Equipment; and 771 R/M Vehicles to be**  
12 **effective October 01, 2010 through September 30, 2011, and requests authorization to**  
13 **expend these funds; and**

14 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
15 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
16 **adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **approve Budget Amendment #1 which decreases the Food Distribution Program Tribal**  
19 **Funding by \$10,572.77 and decreases line item 610 Salaries; 620 Fringe Benefits; 630**  
20 **Insurance; 661 Mileage POV; 712 gas, oil and coolants; 770 R/M Equipment; and 771**  
21 **R/M Vehicles to be effective October 01, 2010 through September 30, 2011 and requests**  
22 **authorization to expend these fund.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
28 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2)&(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**


