

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance –**  
**FY2011 Food Distribution Program Budget Amendment #1 - Account No. 11-1315)**

**RESOLUTION NO. 11-391**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**  
2 **Assistance Division, Food Distribution Program under an FY2011 grant with the United**  
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution Number 10-311, the Tohono O'odham Legislative Council approved the**  
5 **FY2011 Food Distribution Program budget in the amount of \$192,139.08; and**

6 **WHEREAS, the Nation was notified of the final grant award for the FY2011 USDA budget in the**  
7 **amount of \$203,962.84; and**

8 **WHEREAS, the Food Distribution Program funds available to the Tohono O'odham Nation for**  
9 **FY2011 through the USDA has increased a net of \$11,823.76 from the original budget**  
10 **amount of \$192,139.08 to the new budget amount \$203,962.84; and**

11 **WHEREAS, the Department of Health and Human Services has prepared the attached FY2011**  
12 **USDA Food Distribution Program Budget Amendment #1 which increases the budget**  
13 **by \$11,823.76; and increases line items: 610 Salaries; 620 Fringe Benefits; 712, Gas, Oil**  
14 **and Coolants; 721 Supplies Other; 771 R/M Vehicles; line item 900 Indirect Cost at**  
15 **\$1,029.37 from the original budget and has added a new line item 710 Utilities; and**

16 **WHEREAS, the Executive Branch obtained committee approvals of the Family Assistance, Food**  
17 **Distribution Program amendment #1 of \$203,962.84 which is attached and**  
18 **incorporated by this reference to be effective October 1, 2010 through September**  
19 **30,2011 and requests authorization to expend funds; and**

20 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
21 **of the Legislative Council have reviewed this budget amendment and recommend its**  
22 **approval and adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
24 **approve Budget Amendment #1 which reflects the final grant award in the amount of**  
25 **\$203,962.84 which increases the budget by \$11,823.76; and increases line items and**  
26 **adds a new line item to be effective October 01, 2010 through September 30, 2011.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
28 **Chairperson and any designated official to expend and administer the budget as**  
29 **attached, provided that any amendments affecting the funds or funding level shall be**  
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




