

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Veronica La Motte Darnell as a Judge Pro Tempore to the Tohono
O'odham Judicial Court)**

RESOLUTION NO. 11-394

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint judges**
2 **to the Tohono O'odham Judicial Court (Constitution of the Tohono O'odham Nation,**
3 **Article VIII, Section 3); and**

4 **WHEREAS, the Legislative Council "may upon the recommendation of the chief judge appoint pro**
5 **tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2, Section 1201); and**

6 **WHEREAS, the term of a judge pro tempore "shall be set forth in the resolution of the Legislative**
7 **Council appointing the judge, but in no case shall the term be longer than six years"**
8 **(6 T.O.C. Chapter 1, Article 2, Section 1204); and**

9 **WHEREAS, the chief judge has submitted Ms. Veronica La Motte Darnell's resume and letter of**
10 **interest and recommends her appointment as a judge pro tempore to the Tohono**
11 **O'odham Judicial Court; and**

12 **WHEREAS, Ms. La Motte Darnell meets all the qualifications under Section 1203 of 6 T.O.C.**
13 **Chapter 1, Article 2; and**

14 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the**
15 **Tohono O'odham Judicial Court, has interviewed Ms. La Motte Darnell and reviewed**
16 **her resume and letter of interest.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints**
18 **Ms. Veronica La Motte Darnell as a judge pro tempore to the Tohono O'odham Judicial**
19 **Court for a term beginning on September 1, 2011 and ending August 31, 2013.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
21 **of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 3 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
