

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Rachel Johnson as a Judge Pro Tempore to the Tohono O'odham
Judicial Court)**

RESOLUTION NO. 11-396

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint judges
2 to the Tohono O'odham Judicial Court (Constitution of the Tohono O'odham Nation,
3 Article VIII, Section 3); and

4 WHEREAS, the Legislative Council "may upon the recommendation of the chief judge appoint pro
5 tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2, Section 1201); and

6 WHEREAS, the term of a judge pro tempore "shall be set forth in the resolution of the Legislative
7 Council appointing the judge, but in no case shall the term be longer than six years"
8 (6 T.O.C. Chapter 1, Article 2, Section 1204); and

9 WHEREAS, the chief judge has submitted Ms. Rachel F. Johnson's resume and letter of interest
10 and recommends her appointment as a judge pro tempore to the Tohono O'odham
11 Judicial Court; and

12 WHEREAS, Ms. Johnson meets all the qualifications under Section 1203 of 6 T.O.C. Chapter 1,
13 Article 2; and

14 WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the
15 Tohono O'odham Judicial Court, has interviewed Ms. Johnson and reviewed her
16 resume and letter of interest.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints
18 Ms. Rachel F. Johnson as a judge pro tempore to the Tohono O'odham Judicial Court
19 for a term beginning on September 1, 2011 and ending August 31, 2017.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day
21 of AUGUST, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
23 Section 3 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).


