4 **approved a budget amendment for Palo Verde Stand Community (*Amendment #3,***
5 ***Resolution #1107-044*); and**

6 **WHEREAS, on August 5, 2011 at a regularly scheduled meeting, the District Council also approved**
7 **a budget amendment for Florence Community (*Amendment #2, Resolution #1108-059*);**
8 **and**

9 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
10 **the district's budget amendments for Palo Verde Stand and Florence communities**
11 **submitted by the Gu Achi District and recommend for approval.**

12 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Fiscal Year 2011 Budget Amendments for Palo Verde Stand Community**
14 **(*Amendment #3*) and Florence Community (*Amendment #2*) with attached**



9 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
10 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat. 984).


